Manager Mayo reported: 1) Attended meeting on the airport reconstruction and four bids were received; 2) Kiwanis has asked for a free pass to the transfer station like last year; 3) The pump went on the Fire Departments Pumper truck and it will cost \$11,000 to fix it.

SECOND READINGS
