Council President Mahan called the meeting to order at 7:00 p.m.

Councilor Klitch, seconded by Councilor Nuttall, moved to approve the Minutes of the February 20, 2018 Special Council Meeting. *Approved all in favor*, 5-0.

Item #4: Resolved, the Old Town City Council hereby accepts an after deadline redemption on foreclosed property for Robyn R. #### **NEW BUSINESS**

The City Council considered authorizing the City Manager to take all necessary steps to retain Tax Acquired properties pursuant to the mature tax lien process. Both properties currently have buildings that will need to be razed.

Assessor Travis Roy explained that Public Works plow trucks have a hard time turning around at the end of Grays Lane and this would give them the space to take care of that.

Cemetery neighbor Doug Shorey stated he has been waiting for the Bennoch Road property to go up for sale as he lives by it. He would like to bid/purchase on the property.
