# **Regular Council Meeting Minutes December 2, 2019**

Council convened December 2, 2019 in the Old Town City Council Chambers, 265 Main Street

## **Approval of the Minutes**

Motion made by Councilor Smart, seconded by Councilor Ketchen.

Resolved, the Old Town City Council hereby approves as presented the November 18, 2019 Special Council Meeting minutes. *Approved, all in favor, 6-0, 1 abstained.*

Resolved, the Old Town City Council approves scheduling a second hearing on December 16, 2019 for final approval on a Sex Offender Residency Restriction Ordinance, Revised Code of Ordinances, Chapter 12 Nuisances and Miscellaneous Provisions, Section 12-50.

5. Resolved, the Old Town City Council hereby authorizes Finance Director, Danielle Berube, to write off the uncollectable sewer charges, interest, and lien costs for City acquired property for and 70 Front Street in the amount of \$1617.43.

6. Resolved, the Old Town City Council hereby approves City Manager, Bill Mayo, to purchase Maple Grove Cemetery in the amount of \$3800.00 and to sign any necessary documents pertaining to the sale.
