Special Council Meeting Minutes October 21, 2019

Approval of the Minutes

 - 1. Councilor May asked City Manager Bill Mayo if he could look into removing some of the jersey barriers on Main Street as some are in the way of sidewalk use. Mr. Mayo

replied that he would review the placement of the barriers and make a decision with public works on which ones, if any could be removed.
