- 1. John Rouleau, Public Works Director, updated the Council on the downtown Signal design project. He stated that the survey has been completed and the design phase would be in fall of 2021, with projected construction starting in 2022.
- 2. John Rouleau, Public Works Director, discussed to the Council on the Landfill status at the Gilman Falls transfer station. He laid out three scenarios as to the final closing of the landfill.
 - A. Close landfill now. Estimated cost \$590,400, reimbursement of \$350,000
 - B. Check on the license to operate.
 - C. A full removal of everything- would all go to Junipar Ridge. Kyle Smart asked if this option is done will the land eventually be viable to be used or sold and John Rouleau said yes it would.
- 3. John Rouleau also updated the City Council on the DOT Bridge extension.

- Bill Mayo, City Manager told the council that the Boat launch at Cooks Pt is done.
- Discussion with the council was made on reopening the Playgrounds in the City. Bill Mayo, City Manager told the council he talked to Bangor and Brewer about what they are doing regarding the opening of their playgrounds as in sanitizing. Bangor sanitizes once a week and Brewer does not at all. They have signs that state this. Travis Roy interjected that we would have to sanitize between each child and that would not be effective. The council approved opening the playground with the restriction that signs would be posted stating the City would not be sanitizing, distancing rules, wash your hands and sanitize before playing and after playing on the Playground.

of an Easement to Bangor Gas Company, LLC for utility purposes of installing an
underground gas line from Jefferson Street to 45 Lincoln Street and further
authorizes the City Manager to execute said Easement.

2. Resolved, the Old Town City Council hereby sell a piece of a property as shown on Assessor's Map 22, Lot 10-B to Mr. & Mrs. Paradis of 202 Stillwater Avenue, with a maintenance easement for the entirety of the parcel to the City of Old Town, in an amount to be determined by the City Assessor in accordance with past practice. This parcel measures approximately 32' x 130', or, 4,160 square feet. (.0955 acres). Actual dimensions will be verified in the field by a licensed surveyor and reflected accurately within the deed. The Paradis will be responsible for the surveying of the property, deed description, the recording of the deed, any legal expenses and for any and all other cost associated with this transaction. The Council further authorizes the City Manager to execute said sale.

3. Resolved, the Old Town City Council hereby approves entering a purchase and sale of Real Estate agreement between the City of Old Town and Michael A and Lisa M. Burton for 272 Main Street shown on Assessor's Map 26, Lot 3 for the agreed upon purchase price of \$18,500. The City Council authorizes Finance Director to transfer \$18,500 from fund Balance 10-3800-00 to 01-045-4851 and expended from 01-120-60-6400 capital outlay and further authorizes the City Manager to execute said agreement as recommended by the Old Town Development, LLC. Motion to amend the purchase price to add in closing costs was made by Councilor Brissette.
