(Roll call vote), *Approved all in favor*, 7-0

3. President Smart asked for a motion to amend Section 5, listed as Workshop Session in the Rules of Order and Procedure packet to include public in the sentence. The sentence will now read, the Press and public shall now be notified and permitted to attend. Motion made by Councilor Folster, seconded by Councilor May (Roll call vote) Approved all in favor, 7-0
