- Resolved, the Old Town City Council hereby accepts an after- deadline redemption on foreclosed property for Robert Leighton for a 2018 sewer lien at 31 Chapman Street, account # 1966 in the total amount of \$700.73. The City Council further authorizes the City Manager to execute a Municipal Quit-Claim Deed. Motion made by Councilor Smart, seconded by Councilor Brissette, Approved all favor, 6-0
- 2. Resolved, the Old Town City Council hereby accepts an after- deadline redemption on foreclosed property for Robert Leighton for a 2018 sewer lien at 2 Howard Street, account # 9994 in the total amount of \$313.43. The City Council further authorizes the City Manager to execute a Municipal Quit-Claim Deed. Motion made by Councilor Brissette, seconded by Councilor Smart, Approved all favor, 6-0
- 3. Resolved the City Council hereby authorizes the City of Old Town to enter into a rental agreement with Central Equipment for the purpose of Renting a sidewalk snowplow for \$4500/ per month, estimated rental will be for 3 months. The city council also authorizes John Rouleau, Public Works Director to take all actions

necessary to complete said rental contract. Motion made by Councilor Folster, seconded by Councilor May, Approved all favor, 6-0

- 4. Resolved, the Old Town City Council hereby approves a lease Agreement with Quirk Chevrolet for a curtesy transportation vehicle at the Old Town Airport. Lease payment of \$363, will be coming out of the Hanger Rental account # 09-520-25-5300 for the 36-month term. The City Council further authorizes City Manager, Bill Mayo, to take any and all action deemed necessary to complete the lease process. Motion made by Councilor Smart, seconded by Councilor May, *Approved all favor*, 6-0
- 5. Resolved, the Old Town City Council hereby approves establishing a revolving loan fund, as recommended by the Finance Committee, in the amount not to exceed \$100,000 for the purpose of loaning funds to Old Town Orono (OTO) Fiber for the purpose of financing drops to homes and business in Old Town along current and future fiber infrastructure. The City Council authorizes the City Manager to establish the terms of the revolving loan fund. The account will be established from the Economic Development Reserve account # 09-516-25-5410. Motion made by Councilor Brissette, seconded by Councilor May, Approved all favor, 6-0
- 6. Councilor Folster made the motion to table an item for road improvements on the Penny Road until more discussion and bid pricing could be attained. Motion made by Councilor Folster, seconded by Councilor Brissette, Approved all favor, 6-0
