# Finance Committee Minutes October 19, 2020

Finance Committee members convened October 19, 2020 in the Old Town City Council Chambers, 265 Main Street

Committee members present – Councilor Kyle Smart (chair), Councilor Shirley Brissette, Councilor Carol May and President Stan Peterson

Administration present – Bill Mayo, John Rouleau, EJ Roach, Travis Roy, Danielle Berube, Laura Engstrom, Irene Pehrson, Cindy Jennings and David Smith.

Councilor Smart called the meeting to order at 6:00 p.m.

- 1. Danielle Berube, Finance Director, updated the Committee on the September 2020 financials.
- 2. John Rouleau, Public Works Director discussed to the Council about renting a sidewalk snowplow from General Rental. The rental price would be \$4500/ month and he said Public Works would rent it for about 3 months this winter. Motion made by President Peterson to move it to the Regular Council meeting on Nov. 02, 2020, seconded by Councilor May. Approved all in favor 4-0
- 3. E.J Roach, Economic Development Director discussed establishing a revolving loan fund not to exceed the amount of \$100,000, for the purpose of loaning to Old Town Orono Fiber (OTO Fiber), on an as-needed basis, for the purpose of installing fiber drops within the City of Old Town along existing and future OTO fiber infrastructure. The council stated that the money could possibly come from the LLC. Motion made by President Peterson to move it to Regular Council Meeting on Nov. 02, 2020, seconded by Councilor May. Approved all in favor 4-0
- 4. E.J Roach also discussed paving of the Penny Road to accommodate anticipated job growth of Global Secure Shipping and discuss future economic development in and around the Penny Rd. The Council asked about if the money could come from TIF funds and if soil sampling could be done to determine if the road needed any more repair before it needed to be paved. Motion made by Councilor Brissette to move it to

Regular Council Meeting on Nov. 02, 2020, seconded by Councilor May. *Approved all in favor 4-0* 

- 5. Bill Mayo, City Manager stated that Lance Farrar (absent), Airport Director was going to ask the Council to consider authorizing a municipal lease agreement for 5 years with Darlings Ford for a 2020 SUV. The funds will come from the hanger reserve account. Currently, they did not have any lease agreements to present to the council. Motion made by Councilor May to move it to Regular Council Meeting on Nov. 02, 2020, seconded by Councilor Brissette. Approved all in favor 4-0
- 6. Travis Roy, Assistant Manager told the Council that an abutter of City Property on Tax Map 3, lot 32C would like to purchase the land. The land is 21 acres and land locked. The council discussed opening it up to bid for all abutters of said City Property. Motion made by President Peterson to move it toa Regular Council Meeting when said bids are in, seconded by Councilor Brissette. Approved all in favor 4-0
- 7. Bill Mayo told the City Council that Habitat for Humanity would like to transfer property at 1064 West Old Town Road that they are not using right now to the Old Town Rotary club for the purpose of a placing a home on the property for Hospice care. Motion made by Councilor Smart, seconded by Councilor Brissette. Approved all in favor 4-0
