## In order to be approved for a taxicab driver's license, an applicant must:

- Present a valid State of Maine driver's license.
- Demonstrate to the City Clerk that he or she can read, write and speak the English Language.
- In the case of a new application, have his or her photograph taken at a place, time and date designated by the Chief of Police or his or her designee, for City photo identification to be worn in a conspicuous place on the licensee's uniform at all times while operating a taxicab within the City of Old Town. In the case of a renewal application, the applicant must present their City photo identification.
- Demonstrate to the Chief of Police, or his or her designee, that the applicant is at present of such good moral character that the applicant can be trusted with the safe care and custody of taxicab passengers.
- No license will be issued until the results of the State Bureau of Investigation (SBI) criminal background check are received and found to be acceptable by the Chief of Police, or his or her designee.
- Have no outstanding warrants of arrest in Maine or any other jurisdiction.
- Not be a convicted sex offender who is required to register as a sex offender within the State of Maine or is on the national sex offender registry.

Failure to meet any of foregoing requirements shall be grounds for denial of a taxicab license.



## Application for Taxicab Driver's License

In determining whether the applicant is competent to operate a motor vehicle safely and in accordance with law, the Chief of Police shall consider factors including but not limited to whether the applicant has any of the following:

- Three or more convictions for motor vehicle violations within the past three years.
- One or more major moving violations within the past three years, including but not limited to attempting to evade the police, operating under the influence, reckless driving or driving on a suspended or revoked license.

In determining whether the applicant is at present of such good moral character that the applicant can be trusted with the safe care and custody of passengers, the Chief of Police, or his or her designee, shall consider factors, including but not limited to, whether the applicant has been convicted, within in the past 7 years, of any of the following:
