## PUBLIC HEARINGS & READING OF ORDINANCES

Councilor Mahan, seconded by Counsilor Smart, Resolved, the Old Town City Council hereby approved Appropriation Resolution 2019-1 of the proposed FY 2019-2020 Municipal, County and School Budget. The proposed budget calls for City expenditures of \$10,935,814, Penobscot County Taxes of \$657,253 and RSU #34 expenditures of \$5,407,292 for a total City, County and RSU #34 Budget of \$17,000,359 with total City revenue of \$6,943,975 for a net property tax requirement of \$10,056,384; amended to add additional municipal revenue sharing to lower property taxes and to fund \$40,000 from the Economic Development LLC and \$40,000 from city expenditures to fund a full-time Economic Development position.
